#### Faith in Action

Hello!

Happy Spring! I have now experienced every season with Faith in Action, as I just recently celebrated my first anniversary as Executive Director. What a year it has been! Spring, Summer, Fall, and Winter...each season beautiful, busy, and blessed! Every morning, as I arrive at work and park my car, I send a photo and brief text message to my husband to let him know that I have arrived safely. He responds with an encouraging message and good wishes. It's a great way to start the day! A typical day in the office involves answering and returning many phone calls, responding to emails, scheduling appointments for Care



Receivers, coordinating that schedule of appointments with our Volunteers, processing applications, and taking care of necessary business—paying bills, sending out cards and other correspondence, training new volunteers, making bank deposits, preparing for board meetings and public presentations, ordering supplies, making trips to the post office, and always brainstorming ways to better meet the needs of those we provide services to in our community, while also hoping and praying for the people and resources to help make that possible. There are grants to be written and deadlines to meet. There's a lot going on IN the office, and also OUTSIDE the office, as our wonderful Volunteers crisscross the community from the country roads of rural eastern Cabell County to the gently rolling hills of Wayne County...over the river to Lawrence County, Ohio,...up and down the streets of downtown Huntington and in and out of neighborhoods from Lavalette to Milton, and C-K to Barboursville! They have provided our Care Receivers with transportation to doctor and dental appointments, physical therapy, hair appointments, grocery shopping, libraries, and banks. They have accompanied them to medical procedures that require someone being present with the patient. Food boxes are often picked up and delivered, as well as other personal items that a Care Receiver may need. Reassurance Calls are made to provide friendly conversation and to let our Care Receivers know that someone cares about them. Many times, we receive requests for someone to help with simple household chores. Recently, a Care Receiver needed help getting his dog to the veterinarian for shots. Our Volunteers have met these needs and more. They are truly living up to the name FAITH IN ACTION, as they serve others. I recently spoke with our founder and first Executive Director, Laura Gilliam, who shared memories of her time with Faith in Action of the River Cities and expressed her gratitude for being able to help organize and "lay the groundwork" to assist in bringing together those who need help and those who want to help others. Those early efforts have allowed us to build on "solid ground," thanks to the wonderful work and faithful service provided by Laura and countless others in our 28 year history! Like Laura, I too, took a "leap of faith" in accepting this position with Faith in Action. We both agreed that serving in this position was an answer to a calling. It has been a blessing to witness the many ways Faith in Action has made a difference in the lives of not only those being served, but also those who serve. The dream and vision that Laura Gilliam had in 1996 continues today. With your continued support, we can help enhance the quality of life for older adults and chronically disabled individuals within our communities for many years to come!




