### **A SPECIAL MESSAGE FROM JENNIFER PLYBURN & BOB WOOD**

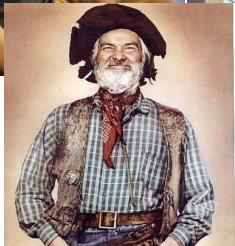
